

Withdrawals	<p>Any player failing to participate in any UPBA approved tournaments after draw is made, he/she is liable to pay the entry fees as a fine to UPBA before participating in next tournament. District Association/Club shall ensure for the deposition of the withdrawal fee to UPBA.</p> <p>No exemption under any grounds (including medical) will be allowed in payment of fine. No player is permitted to participate in the next tournament without paying fine. Referee shall submit the withdrawal list to UPBA within 48 hours after completion of the tournament.</p>				
Mode of Completion	<p>All matches shall be played on best of three games in rally point system. However if needed the Referee in consultation with Organizing Secretary may take the decision as per need of the situation.</p>				
Regulations	<p>The General Competition Regulations shall be applicable. In the event of any dispute, the decision of the Tournament referee will be final.</p>				
Clothing Regulations	<p>Players must comply with General Competition Regulations.</p>				
Draw	<p>Draw will be made on 14th June 2023</p>

Organizing District Association/Club will provide the space for Yonex stall at venue if required. 				
Protest	<p>Any protest during the tournament can be given prior to the match or within 30 Minutes of completion of the match. The protest along with the protest fee will be submitted to Referee.</p> <p>a) The Referee will check the documents of the said players if satisfy</p>

(b) If the referee will not be able to verify the documents then he will submit the protest case to Organizing Secretary, so that he can forward the case to UPBA.

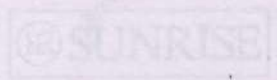
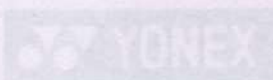
Note :
